The Role

You will report directly to the Head of Certifications and support him on project initially and then taking on ownership of your own projects once you are settled in and comfortable with our approach.

Your tasks will include:

1. Assessing clients against the requirements of ISO 27001 and creating detailed gap assessment reports.
2. Utilising our existing framework to draft policies, processes and procedures for clients to review and for you to assist in their implementation.
3. Facilitate and deliver ISO 27001 workshops including risk assessment, internal auditing and business continuity requirements.
4. Advising on implementation of ISO focused controls required to address security risks.
5. Carrying out or supporting our clients with internal audits, management reviews and the documentation of audit reports.
6. Maintaining ISMS', corrective action logs, delivery trackers and client progress reports etc.
7. Assisting with the maintenance of Fortis's own ISO management systems.
8. Working proactively and collaboratively with certification bodies

The Person

The ideal candidate will have at least 5 years' experience in implementing an ISO 27001 certified ISMS. This may be as a consultant or in an employee.

You will understand the fundamental requirements of ISO 27001 including all clauses. You will also understand the requirements of the controls listed at ISO 27001 Annex A and the sub-controls within ISO 27002.

You will be a self-starter who will fill in gaps in your knowledge through continued professional development. You will be happy to research standards and best practice and to tackle new topics and be interested into expanding to new areas such as CIS controls auditing.

Great communication and writing skills are essential, as report drafting is a key part of the job. You will also need to be comfortable working with clients in leadership roles, as well as technical personnel on your own.

You will need to exhibit an open and positive attitude towards clients and internal staff alike and able to prioritize effectively to ensure commitments are met.

It is desirable that you have attained one or more recognised security certifications, which could include:

1. ISO 27001 or ISO 9001 Lead Implementer
2. ISO 27001 or ISO 9001 Lead Auditor
3. CISSP

If you don't have these certifications Fortis would put together a package to help you achieve them.

The Package

The salary will depend on your experience and qualifications and will be in the range of £55,000 to £70,000 depending on qualifications and experience.
